

I. COOKIE POP UP

In order to provide you with personalized service, Lazer Telecom (hereinafter referred to “we”, “us”, “our”) uses “cookies” to keep and occasionally track information about your visits to our website. We use this information to help make the site more useful and reliable and to give you the best experience on our website.

II. WHAT IS A COOKIE

A cookie is a small text file that is stored on your computer or mobile device by a website’s server to improve your user experience and gather analytical data about how the site is being used. Cookies are saved on the hard drive of your device by means of your browser, enabling us to recognize your browser for purposes such as saving your preferences and directing relevant content to you. A cookie in no way gives us access to your computer, device or any information about you, other than the data you choose to share with us.

III. HOW WE USE COOKIES

We may place a cookie on the hard drive of the device that you use to access the Service. The cookies that we use may be persistent cookies (which are cookies that will continue to exist even after the given browser session is closed) or session cookies (which are cookies that only last for a given browser session). This helps us to provide you with a good experience when you use the Service and also allows us to improve our Service. The cookies that we use may record details of transactions you carry out through the Service. Details of your visits to the Service including, but not limited to, traffic data, location data, weblogs and other communication data may also be collected.

Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control and in respect of which we will have no responsibility. By using the Service (with your browser settings set to accept cookies) you are consenting to the use of cookies as described in this Cookies Policy.

When we use cookies in relation to the Service, we will do so in accordance with the provisions of Articles 5(3) – 5(5) of the European Communities (Electronic Communications Networks and Services) Privacy and Electronic Communications) Regulations 2011.

We make use of analytics services such as Google Analytics which set cookies to identify which pages are being used on our website. By using cookies, Google Analytics collects and stores data such as time of visit, pages visited, time spent on each page of the website, the Internet Protocol address, and the type of operating system used in the devices used to access the Service. We use this information for statistical analysis purposes. We may also use third party applications or provide content on our website (such as Google Maps) that may set cookies when you interact with them. We use session ID cookies on the sites to make it easier for you to navigate our website. A session ID cookie expires when you close your browser.

IV. WHAT IF YOU DON’T WANT COOKIES TO BE SET

Most of the currently available browsers give you the option of managing cookies by, for example, disabling them entirely, accepting them individually, and deleting saved cookies from your hard drive. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies. The most effective way to disable cookies is in your browser’s ‘Help’ section or taking a look at the ‘About Cookies’ website which offers

cross-browser guidance. We would like to remind you that if you completely disable cookies on your browser, you might not be able to use some features of the Service.
